Furthermore, in consideration for the privilege of becoming members of the Bowen Island Trail Society, I/we on behalf of myself/ourselves individually, and on behalf of all children under the age of majority of whom I/we am/are legal guardians LISTED BELOW, and on behalf of my/our and their heirs, executors, administrators, successors or assigns, hereby agree to and will indemnify the Bowen Island Trail Society, its officers, directors, employees, agents, successors, assigns, representatives, contractors, licensees and invitees and each of them and hold them harmless from any and all losses, claims, damages, demands, actions, judgments, executions, suits, filing fees, costs of collection, and attorney fees on a solicitor-client basis.

This agreement has been made in and for all purposes shall be construed in accordance with and governed by the laws of the Province of British Columbia, and the parties agree to attorn to the jurisdiction of the courts of British Columbia.
